A vote was taken on this and 21 home groups were in favor of not having ASC in April so that the audit could take place, 1 home group was opposed, and 2 abstained. There will be no JAC and ASC meetings in April but they will return in May as usual.

## SWANA Area Service Committee Sub-Committee Report - Convention Treasurer SWACNA XIV

Date: 16 March 2022

Our area's 14th convention, **SWACNA XIV**, is now concluded (held on the dates of **10-13 March 2022**) and was a financial success - through the hard work and dedication of our convention sub-committee members, and the participation of so many pre-registered and on-site registered attendees, we were able to not only fully pay for this convention's liabilities and contract costs, but we also sold out of the paid events on Friday, which has never before happened.

The contracts with Sodexo Operations, LLC (d/b/a the **Chase Center** on the Riverfront) and the **Westin Hotel** in total came to \$33,075.71. It is anticipated that the next convention, with current inflation rates, may cost the area at least \$35.7K due to rising costs for 2024.

The Small Wonder Area provided startup funds in the amount of \$12,424.27 as we began our work. This convention had a financial goal to provide needed funds back to the area, and provide at least the starting funds left for this committee, for the next. We exceeded that goal by 12.8% and raised an additional \$1,589.92 over projections.

The convention storage unit is fully paid through the end of this month, 31 March 2022. It is anticipated that the monthly cost for the next year (based on the \$88/month charged in October of last year) will be \$1,056 per annum.

Of note when choosing members to hold positions of financial trust during this and future conventions, I wanted to point out that over the course of the past four year period, starting May 1st, 2018 through today, the convention brought in a total of\$84,125.02 and spent \$77,535.10 which represents a total of \$161,660.12 of funds being touch by the hands of those on your committee. Strong financial controls were in place, but there is significant room for improvement and better record-keeping by the endpoints of the team. We were a very small committee so the work was often fast and furious, and we together were the major checksand-balance for keeping funds safe - which we did with patience and

#### transparency.

Our SWACNA XIV convention committee has satisfied ALL of our liabilities, which include reimbursement to the area for 1/2 of the annual liability insurance premium (Philadelphia Insurance Company policy PHPK2218188 through 22 Feb 2023) in the amount of \$904.50, and transfer of funds to support the area (25% of the post-convention balance) in the amount of \$4,671.39 as required by the SWANA bylaws Article IX - Section B 4 (i).

The following committees provided the funds to make this convention a reality through their hard work (net income over expenses):

Registration: \$24,101.89 Fund Raising & Entertainment: \$9,746.62 Programming: \$4,019.01

Merchandise: \$2151.77

#### Some fun with numbers and metrics:

The SWACNA XIV Committee was in place 1409 days
This Committee held a total of 20 SpeakerJams at 8 locations
The Committee members spent an estimated 3,440 man hours
The Convention Treasurer wrote 138 checks, and made 81 deposits

The Convention Treasurer has maintained and prepared sufficient records to provide for a thorough audit of records. I will be providing more details and metrics of each of our fundraisers and other details n those records for the benefit of analysis and assistance to the next convention.
