**Motions:**

There was a motion made by John R., the Policy chair, to reconsider and possibly rescind the motion for the Literature Co-Chair to be elected by area. Per policy it states that the literature co-chair should be a member of the subcommittee and elected by the subcommittee, but a motion was passed this month for the co-chair to be elected by area with the intent that it will bring more accountability because of the amount of money that is being handled. Some members of ASC opposed this motion because it had been voted upon and passed. A vote was taken during the February ASC meeting to reconsider or rescind the motion to have the Literature Co-Chair elected by ASC and 2 voted to reconsider the motion, 18 were opposed, and 4 abstained. The motion was to NOT rescind or reconsider the passed motion for ASC to elect the Literature Co-Chair and this motion passed, so therefore it is in place that the policy will need to be changed to reflect that ASC will elect the Literature Co-Chair. There are nominations for this position (as mentioned above), and the vote will be taken at the March ASC meeting. Please see the nomination forms for more information.

**OPEN FORUM**

During open forum various issues were discussed.

Unity and Activities requested their full budget (\$400) for the Outreach event that is being held in March.

Outreach requested their full budget (\$30) for this month as well so that literature can be purchased for their upcoming workshop.

The Policy Chair, John R., highlighted that according to policy subcommittees are to have a six (6) month budget prepared in February. The subcommittees need to work on their budgets and have them ready for the next meeting of ASC.

The topic of an Ad Hoc Committee for audits was again discussed. If an Ad Hoc Committee is not formed and does not start working soon to audit all of the financial records for area, then there will likely need to be a suspension of area business for two months in order for this an audit to be done.

1. We will meet in person and hybrid at the following location.

2. A brief review of the responsibilities of the policy chair and committee:

Pg. 57 Sec VIII-8 Also we discussed if the policy presents an ambiguous situation, we are to figure out what's salient to present to the JAC/SWA for discussion.

3. Clarity on the following:

Can a member be a Subcommittee Chair and GSR at the same time? After review of the policy, (pg. 21 Sec. VI-3 D. bullet 4) we found that only the ASC officers are addressed. And there is no clarity on the subject matter in the policy. But the overall consensus is yes you can be a Subcommittee Chair and GSR at the same time. The policy will be adjusted if needed at a later date after further review and discussion.

4. Discussion on finishing the Appendix section of the policy was discussed.

5. Preparing our annual budget, and the annual policy for the Home Groups was discussed.

6. How to fill out the motion form heading was discussed. A brief discussion on making sure the heading is filled out will be presented to SWA. It allows the GSR's and Policy Chair to easily locate in the policy if a change is to be made. If it does not apply to a Policy change then NA should be put in that section.

7. As the policy committee the motion for literature co-chair was discussed we found that it is violation of the policy. I asked if the motion would change any part of the policy? They said no when in fact it will. We would have to change the wording in 2 locations and probably more after review. Review pg. 35 VIII-1 (A) second bullet. "Subsequent officers of the subcommittee will be elected by the subcommittee's members." And Pg. 48 Literature Co-chair requirements second bullet. "Should be a subcommittee member." If the motion fails it becomes moot. If not a motion to rescind will be requested.
