## SWACNA XV Treasurer's Report

March 20, 2024

*Note: All numbers are rounded to the nearest dollar.*

The SWACNA XV Convention Body had its first event in September 2022 and has since completed 19 fundraiser events. Our committees raised \$69,681, an amount that does not include the seed money from the previous convention.

We paid the Convention Center a total of \$31,000, which is what we estimated from the beginning. It's important to note that the next contract with the Convention Center is much more specific regarding costs from the beginning of the process to avoid any last-minute surprises. For example, our contract didn't mention anything about the banners and the prior convention's contract only mentioned delivering the banners, not hanging them. We tend to work off of "what was done before," but staff changes at the Convention Center make that system unreliable.

SWACNA XV's beginning balance on Feb 1<sup>st</sup>, 2024, was \$9,794. Our reconciled balance on Feb 29, 2024, was \$6,485. Our balance going into the Convention weekend was \$6,861. We gave the Convention Center a check for \$5,000 toward our final balance, leaving us with \$1,861 as we opened on Friday, March 8<sup>th</sup>.

During the Convention, we brought in a total of \$19,038. Our debits included \$644 in costs, and we withdrew \$600 to provide change during the weekend. The balance of \$17,793 plus our bank balance of \$1,861 gave us a total of \$19,654 at the end of the Convention. This enabled us to pay the Chase Center a balance of \$6,000, leaving us with \$13,654.

Today, I have a check for \$904.50 for the Area, which is 50% of the insurance policy. I have another check for the Area in the amount of \$3,187.67, which is 25% of our net proceeds, leaving the next convention seed money of \$9,563.



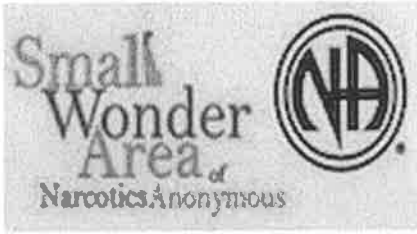
