I told you last month that I'd have a quote for you from the Philadelphia Contributorship for our Area and Convention insurance policy. That quote came in at \$2,114. I'll be paying that in full as soon as I receive the bill, and Convention Body will reimburse SWANA for its half.

Our meeting list price increased slightly due to increasing the number of meeting lists from 1000 to 1500 quantity. The new cost is \$140.10, up from \$97.40.
